## CONSTITUTION

#### FOR

# WASHINGTON STATE PARKS AND RECREATION COMMISSION EMPLOYEES

### **LOCAL 1466**

#### ARTICLE NAME

The name of this organization shall be Washington State Parks and Recreation Commission Employees Local Number 1466 of the American Federation of State, County and Municipal Employees, AFL-CIO.

#### ARTICLE II AFFILIATIONS

This local union shall be affiliated with Washington Federation of State Employees Council No. 28 of the American Federation of State, County and Municipal Employees; the Washington State Labor Council, AFL-CIO; and the appropriate central body of the AFL-

### ARTICLE III OBJECTIVES

The objectives of this local union shall be to carry out on a local basis the objectives of the American Federation of State, County and Municipal Employees.

# ARTICLE IV MEMBERSHIP AND DUES

- Section 1. All employees of the State of Washington in the Parks and Recreation Commission are eligible for membership in this local union, subject to the requirements of the Constitution of the International Union.
- Section 2. Application for membership shall be made on a standard application form. Unless such form includes a valid authorization for payroll deduction of dues, the application shall be accompanied by the current month's dues. the
- Section 3. The monthly membership dues of the local shall be 1.50% of each member's actual salary, each pay period, computed on each individual's salary range and step, exclusive of overtime, including callback and penalty pay, shift differential, standby pay, equipment premium pay, holiday premium pay, terminal leave or sick leave cash-out pay, up to a maximum of seventy-five dollars and zero cents (\$75.00) per month, provided the maximum dues payable shall be increased in direct proportion to the average percentage of general salary increases of state employees, effective the month of implementation of said increase.
- Section 4. Membership dues shall be payable monthly in advance to the local treasurer and in any event shall be paid not later than the 15th day of the month in which they become due. Any member who fails to pay dues by the 15th day of the month in which they become due shall be considered delinquent, and upon failure to pay dues for two successive months shall stand suspended. Provided, however, that any person who is paying dues through a system of regular payroll deduction shall for so long as such person continues to pay through such deduction method, be considered in good standing.

Section 5. A member suspended under the aboumembership in the local on payment of all arrearages. above section may be reinstated

### ARTICLE V MEETINGS

<u>Section 1.</u> Regular meetings of this local shall be held at least four (4) times per year, at a time and place to be fixed by the membership or the local executive board.

meetings Section 2. Special meetings may be called by the local president, the local executive board, or by petition filed with the president and signed by 4% of the members of the local. The International President or his authorized representatives may also call special

# ARTICLE VI OFFICERS, NOMINATIONS, AND ELECTIONS

Section 1. The officers of this local shall be a president, a vice-president, a treasurer, a recording secretary, 6 executive board members, 2 each from the Rangers, Support/Professional Staff and the Construction/Trades job classes. These ten (10) shall constitute the local union executive board. In addition, there shall be elected three members who shall serve as trustees. The trustees shall be elected to three-year terms of office, except that in the initial election, one shall be elected for a one-year term, one for a two-year term, and one for a three-year term. All other officers shall be elected for a term of one year and beginning in 2006, they shall be elected to two-year terms in the evennumbered years

Section 2. Nominations shall be made at a regular or special meeting of the local. At least fifteen days' advance notice shall be given the membership prior to the nomination meeting. A nominating committee may be appointed or elected to make nominations, but whether or not such nominating committee is used, nominations shall be permitted from the floor at the nomination meeting. All regular elections shall be held at the last meeting of the calendar year or by mail in ballot.

Section 3. To be eligible for office, a member must be in good standing for immediately preceding the election, except in the initial election held in this local; however, that no retired member shall be a candidate for office. r one year ; provided,

Section 7. Every officer shall, upon assuming office, subscribe to the Obligation of an Officer contained in Appendix B of the International Union Constitution. Every

# ARTICLE VII DUTIES OF OFFICERS AND EXECUTIVE BOARD

Section 1. The president shall preside at all meetings of the local union and of the executive board; be a member of all committees except election committees and statewide policy committees; countersign all checks drawn against the funds of the local; appoint all standing committees and all special committees of the local, subject to the approval of the executive board; report periodically to the membership regarding the progress and standing of the local and regarding the president's official acts.

- Section 2. The vice-president shall assist the president in the work of the president's office; in the absence of the president or in the president's inability to serve, preside at all meetings and perform all duties otherwise performed by the president; upon approval by the local executive board, be authorized to act as co-signer of checks drawn on the local funds in place of either the president or the treasurer.
- Section 3. membership Section 3. The recording secretary shall keep a record of the proceedings membership meetings and of all executive board meetings; carry on the correspondence of the local, except as the executive board may direct otherwise. of all official
- Section 4. The treasurer shall receive and receipt for all monies of the local union. Helshe shall deposit all money so received in the name of the local union in a bank or banks selected by the executive board, and money so deposited shall be withdrawn only by check signed by the president and the treasurer. Helshe prepare and sign checks for such purposes as are required by the constitution or are authorized by the membership or the executive board. Helshe shall prepare and submit the monthly membership report to the International Union office and see that a check is drawn in payment of the local's per capita tax each month and sent to the International Treasurer. Helshe shall keep an accurate record of receipts and disbursements and shall, at each local meeting, submit to the membership a monthly operating statement of the financial transactions of the local for the previous three months. Helshe shall act as custodian of all properties of the local union. Helshe shall, at the expense of the local union and through the International Union, give a surety bond for an amount to be fixed by the executive board of the local union. Helshe shall see that any financial reports required by the Washington Federation of State Employees or by the International Union Constitution are submitted.
- Section 5. The trustees shall make or cause to be made at least semi-annually an audit of the local's finances, and shall report to the membership on the results of such
- Section 6. The executive board shall be the governing body of the local union except when meetings of the local union are in session. All matters affecting the policies, aims and means of accomplishing the purposes of the local not specifically provided for in this constitution or by action of the membership at a regular or special meeting shall be decided by the executive board. The board shall meet at the call of the president or of a majority of the members of the board. A report on all actions taken by the executive board shall be made to the membership at the next following meeting. A majority of the members of the executive board shall be required for a quorum.

# ARTICLE VIII MISCELLANEOUS PROVISIONS

- Section 1. This local union shall at all times be subject to the provisions constitution of the American Federation of State, County and Municipal Employees. 약
- Section 2. Except to the extent specified in this constitution, no officer of the local union shall have the power to act as agent for or otherwise bind the local union in any way whatsoever. No member or group of members or other person or persons shall have the power to act on behalf of or otherwise bind the local union except to the extent specifically authorized in writing by the president of the local union or by the executive board of the local union.
- Section 3. The rules contained in the current edition of Robert's Rules of Order, Newly Revised, shall govern this local union in all cases to which they are applicable and in which they are not inconsistent with this Constitution and special rules of this local union or of the American Federation of State, County and Municipal Employees.

## ARTICLE IX AMENDMENTS

This constitution may be amended, revised, or otherwise changed by a two-thirds vote of the members voting on such proposed change and such change shall take effect only upon written approval of the International President. Proposed amendments to this constitution must be read at a regular or special meeting of the local union and read and voted on at a subsequent meeting of the local union, adequate and proper notice having been given to the membership prior to the date on which the vote is taken. A written copy of the proposed amendment shall be furnished to every eligible voter at the meeting at which the vote is taken.
